Students of **VIII semester** B.Tech. (Regular) programme are hereby informed that the dates of remittance of semester fee are as follows:

Date of commencement of class : 27.01.2022

1. The date of remittance of I installments of fee : From 27.01.2022 to 25.02.2022

2. The date of remittance of II installments of fee : From 26.02.2022 to 27.03.2022

3. The date of remittance of fee with a fine of : From 28.03.2022 to 06.04.2022

4. The date of remittance of fee with a fine of : From 07.04.2022 to 26.04.2022

₹ **610/-** (Rupees Six hundred and ten only)

Defaulters after **26.04.2022** should remit ₹ **1285/-** towards readmission fee in addition to the late fee of ₹ **610/-** and will not be eligible for attendance till the date of remittance of fee.

Students can also remit their fees by CASH at any S.B.I branch by chalan generation through above Online system. They should remit the cash to the bank on the date of chalan generation itself.
