Students of **II semester M.Tech(FT) (2022 Batch)** are hereby informed that the dates of remittance of semester fee are as follows :

Date of commencement of class	: 08.02.2023
4. The date of remittance of fee	: From 08.02.2023 to 14.02.2023
5. The date of remittance of fee with a fine of ₹ 75/- (Rupees Seventy only).	: From 15.02.2023 to 24.02.2023
6. The date of remittance of fee with a fine of ₹ 640/- (Rupees Six hundred and ten only)	: From 25.02.2023 to 16.03.2023

Defaulters after **16.03.2023** should remit ₹ 2025/- towards readmission fee in addition to the late fee of ₹ 640/- and will not be eligible for attendance till the date of remittance of fee.
